

iCompareFX American Scholarship 2018 Full Terms & Conditions

1. Information on how to enter form part of these Terms and Conditions. Participation in this Scholarship Awards Program (**Program**) is deemed acceptance of these Terms and Conditions.
2. The Scholarship period commences on Friday December 1, 2017 12am (EST) and ends at 11:59pm (EST) on Monday November 20, 2018 (**Scholarship Period**). There will be ONE scholarship winner for the Scholarship Period.
3. To be eligible to enter, Entrants must be:
 - An American resident 18 years or over
 - The applicant must be a full-time student and able to prove they are studying at a College or University in America
 - The Student must be studying in the following disciplines: Marketing, Business, IT, Digital Design or any e-business related field
 - Applications must be submitted via email to scholarship.usa@icomparefx.com.
 - The application must submit the application to iCompareFX from their University / College email account and not a free email account (e.g. Gmail).
4. To enter this Scholarship, the Applicant must email the following:
 - Current Resume/CV
 - Enrollment confirmation letter of the Course and University / College where the applicant studies
 - A letter outlining why this scholarship can help your future career (maximum of 400 words)
5. All valid entries for this Scholarship will be considered by a panel of judges with one scholarship winner announced. The winner will be notified by Thursday November 30, 2018.
6. iCompareFX reserves the right, at any time, to verify the validity of entries and Entrants (including an Entrant's identity, age and place of residence) and to disqualify any Entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions will be accepted at iCompareFX's discretion. Failure by iCompareFX to enforce any of its rights at any stage does not constitute a waiver of those rights.

Friday the December 7 2018 it will be reallocated to the next best eligible entry as determined by the judges (**Alternative Winner**). The Alternative Winner will be notified by email by Friday December 14 2018. The Alternative Winner has two weeks from the day of notification in which to claim their Scholarship or another Alternative Winner will be selected.

11. Applicants consent to iCompareFX using the Winner's name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Scholarship.

If this Scholarship is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of iCompareFX, iCompareFX reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Entrant; or (b) to modify, suspend, terminate or cancel the Scholarship, as appropriate.
